One of the critical issues at this Chapter will be the follow-up on the Province visioning process. In addition, the Chapter will be reviewing the report of the Provincial Council and reviewing and approving further sections of the *Province Directory*. The full agenda of the Chapter will be published in FAMILY ONLINE after the meeting of the Provincial Chapter Preparatory Commission on December 21.

## **Process for Submitting Propositions to the Provincial Chapter**

According to the Manual of Procedures of the Provincial Chapter, the following steps should be followed by those submitting propositions:

1. Propositions sent to the Chapter should contain the following items:
  - A clear, concise statement of the proposition indicating who has responsibility for its implementation (i.e., the Provincial Administration, the Office of Education, the local community, etc.)
  - A second paragraph (the commentary) should state the rationale for the proposal including the principles underlying and supporting the proposition and any information needed for implementation.
2. A printed copy of the proposition should be signed by the individual submitting it and sent to the Assistant Provincial, James Fitz, S.M., the Provincial Council member of the Preparatory Commission. If at all possible, the proposition should also be sent by email to Fr. Fitz at [jfitz@sm-usa.org](mailto:jfitz@sm-usa.org). (It can be sent as an email attachment). Fr. Fitz will acknowledge receipt of the proposition.
3. The Preparatory Commission will assign the proposition to one of the Standing Committees of the Chapter. Every proposition will be reviewed by a Standing Committee before coming to the floor of the Chapter. Each Standing Committee reviews the propositions assigned to it and recommends to the Chapter a proper action to be taken.

**Propositions for the March 2006 Session of the Provincial Chapter must be submitted by *Wednesday, January 31, 2007*.**

Action on propositions submitted after the established deadline given above may be delayed until the next session, unless a Standing Committee deems it necessary to act otherwise.
